TERMS & CONDITIONS

- 1. THE PROMOTER AND THE COMPETITION
- 1.1 The Promoter is Hibernian Community Foundation having its principal office at Easter Road Stadium, 12 Albion Place, Edinburgh, EH7 5QG
- **1.2** The title of the competition is Design a Mascot Competition.

2. ELIGIBILITY

- **2.1** The competition is only open to those of Primary School age. In addition, the following persons, regardless of their age, will not be eligible for the competition:
- (a) employees of the Promoter;
- (b) anyone who is professionally connected with the competition or its administration; or
- (c) members of the immediate families or households of the persons described in paragraphs (a) and (b) above.
- **2.2** By entering the competition, you confirm that you are eligible to do so and that you are eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to enter the competition at any time.
- **2.3** The Promoter will not accept competition entries that are: automatically generated by computer; completed by third parties or in bulk; illegible, have been altered, reconstructed, forged or tampered with; and/or incomplete.

2.4 Entries that are:

- (a) made on behalf of another person;
- (b) joint submissions by two or more persons;
- (c) made by or on behalf of a partnership or company or other body corporate; and/or
- (d) made by a person in his or her capacity as an employee or officer of another party; are not allowed and will be rejected by the Promoter.

3. HOW TO ENTER

- **3.1** Entries must be submitted via email to football@hiberniancommunityfoundation.org.uk or by post to Hibernian Community Foundation Mascot Competition, Easter Road Stadium, 12 Albion Place, Edinburgh, EH7 5QG by the closing date specified in paragraph 4.1 of these terms and conditions
- **3.2** An entry form (in the form specified by the Promoter and made available on the Promoter's website) must also be completed, signed by your parent, guardian or carer and submitted by you alongside each design entry. Without prejudice to paragraph 8.3 of these terms and conditions, each entry form signed by you will contain an acknowledgement that your entry is:
- (a) exclusively your own work and does not comprise or incorporate any copyright or other intellectual property rights owned by any other person;
- (b) is not defamatory or immoral; and
- (c) does not infringe any third party rights and/or any agreements to which you are a party.

Neither the Promoter nor any of its employees, agents or representatives will be responsible for the non-receipt and/or non-inclusion of entries in the competition as a result of being lost, late, illegible, incomplete, invalid, or because of technical failures or otherwise, including such failure which is within the control of the Promoter or its employees, agents or representatives.

- **3.6** The winner will be required to confirm in writing that they have read, understood, and complied with the terms and conditions of this prize draw, and may be required to provide proof of eligibility (including, but not limited to, proof of identity, proof of age and/or proof of residency), as necessary. The proof of eligibility that will be considered suitable for verification is at the Promoter's discretion.

- 3.10 There is no purchase necessary by you to enter the competition and there is no charge for submitting an entry.

4. WINNER SELECTION

- **4.1** One winner will be selected from all eliqible entries received by the closing date at 12pm on Friday 3rd April 2020.
- 4.2 The competition entries will be judged by a panel of at least three judges. The decision of the panel of judges will be final.
- **4.3** By entering the competition, entrants' parents, guardians or carers confirm that they have read and agree to be bound by these terms and conditions, and by the decisions of the Promoter, which are final in all matters relating to the competition. Any breach of these terms and conditions will result in the forfeiture of the prize. No correspondence will be entered into.
- **4.4** The winning entry may be subject to alterations or adjustments by the Promoter or its agents, including, but not limited to, in order to ensure practicality of use.
- **4.5** The Promoter will send the full names of the judges by e-mail to anyone who writes to the Promoter requesting such information within one month of the closing date referred to in paragraph 4.1 of these terms and conditions.

- **7.3** The Promoter reserves the right to disqualify any person it finds, in its sole discretion, to be tampering with the operation of the competition, or to be acting in breach of these terms and conditions and/or in any way that is inconsistent with the spirit of the competition. **7.4** The winner may be requested to participate in publicity arranged by the Promoter or its agents.
- **7.5** Insofar as is permitted by applicable law, neither the Promoter, its representatives, prize providers nor their respective employees, associated agencies and companies or anyone professionally connected with this competition, will in any circumstances be responsible or liable to any entrant and/or the winner in connection with this competition.
